**TOXICOLOGICAL INFORMATION:** VERY TOXIC. Fatal by inhalation. Toxic if swallowed. Target organs are central nervous system, blood, skeletal muscle, liver. Symptoms of overexposure may include drowsiness, jaundice, agranulocytosis, eosinophilia, leukopenia, hemolytic anemia, aplastic anemia, thrombocytopenic purpura, pancytopenia, tachycardia, hypotension, dystonia, tardive dyskinesia, pseudo-parkinsonism, motor restlessness, urticaria, photosensitivity, exfoliative dermatitis, contact dermatitis, constipation, urinary retention, adynamic ileus, priapism, miosis, mydriasis, cerebral edema, ocular changes, hyperpyrexia. Causes photosensitivity. Exposure to light may result in allergic reactions resulting in dermatologic lesions, which can vary from sunburnlike responses to edematous, vesiculated lesions, or bullae. To the best of our knowledge, the toxicological properties have not been thoroughly investigated.
