**TOXICOLOGICAL INFORMATION:** May be harmful by inhalation, ingestion or skin absorption. Target organs are gastrointestinal tract and pancreas. It inhibits gastric acid secretion, and stimulates insulin release. Blood effects. Exposure may cause circulatory collapse. Hypoglycemic and antidiabetic compound. Hypoglycemia symptoms may include tachycardia, tremulousness, sweating, weakness, anxiety, nervousness and hunger. Severe hypoglycemia may cause coma. To the best of our knowledge, the toxicological properties have not been thoroughly investigated.
