ACUTE HEALTH EFFECTS: VERY TOXIC. Fatal by inhalation, ingestion, or skin absorption.

SECTION 4: FIRST AID MEASURES

Extremely dangerous upon entrance of the bloodstream. Symptoms of exposure may include numbness, tingling of the lips and inner mouth surfaces, weakness, paralysis of the limbs and chest muscles, drop in blood pressure. Symptoms of exposure may occur within 10 min. Death may occur within 30 min. To the best of our knowledge, the toxicological properties have not been thoroughly investigated.
