Section 2 : Health Hazard Data

Acute Health Effects: May be harmful by ingestion, inhalation, or absorption through the skin. Material is a potent agonist for the nicotinic acetylcholine receptor. Exposure to material may lead to respiratory arrest.

Chronic Health Effects: There is limited evidence that this compound is teratogenic in laboratory animals. Until further information is available, this compound should be treated as a possible teratogen in humans.

Section 3 : First Aid Measures

Eye Contact: Check for and remove contact lenses. Flush eyes with running water for at least 15 minutes separating eyelids. **Seek medical attention immediately**

Skin Contact: Wash with soap and water for 15 minutes. Remove contaminated clothing and shoes. **Seek medical attention immediately.**
