Section 2 : Health Hazard Data

Acute Health Effects: To the best of our knowledge, the toxicological properties of this compound have not been fully investigated. This compound has been shown to be hepatotoxic and teratogenic in animals. Exercise appropriate precautions to prevent opportunities for inhalation, and to prevent direct contact with skin and eyes. All uncharacterized chemicals should be treated as suspected toxins. **As this material is a suspected teratogen in humans, women who are or may become pregnant should avoid contact with this compound.**

Section 3 : First Aid Measures
